NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

- I. The Author has this day transferred and give into the Trustee a sum of Rs.1,000/- (Rupees One Thousand only) to be held upon trust together with all the income arising therefrom and all the accumulations and accretions thereto for the intent purpose and objects herein contained.
- II. The name of the Trust shall be **ST. THERESA EDUCATIONAL PRIVATE TRUST.**
- III. **The Registered Office** of the Trust shall be situated at No. 6, Anka Reddy Layout, PWD Road, B. Narayanapura, Bangalore-560 016. The Office of the Trust shall be located for the time being at Karnataka and/or such other places as may be decided by the Trustees from time to time.
- IV. **AIMS AND OBJECTIVES:**
 - i) **Education:**
 - a). To establish, maintain, develop, extent, grant, donate for aid, in the establishment, maintain, improve, manage and control Schools, Colleges, Social service centers, Culturaland Social Institutions, Industrial

To organize, establish, maintain, direct, assist in organization and running free medical camps, rural medical services, medical check-ups, detections of diseases, search in eradication of disease, health education and provide all such services, medical kits

iii) **Relief to the Poor:**

- a) To conduct, assist, organize, establish, maintain, run and implement integrated, run development schemes, socio-economic development schemes, pollution control activities and upliftment of poor, downtrodden, slum dwellers, destitute and age old persons.

iv) **Other Services:**

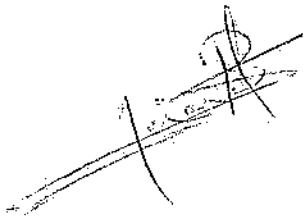
- a) To conduct yoga training camps, meditation camps, human development programmes and social development programmes.
- b) To impart knowledge in the field of cultural, spiritual and social development amongst the general public.
- c) To organize service camp during natural calamities and to serve the sufferers during natural disasters.
- d) To provide amenities for holding discourse on Indian cultural, tradition and way of life.
- e) To print, publish, circulate, distribute and supply literature, pamphlets, hand bills and instructions either free or otherwise to achieve the objects herein above mentioned.

- f) To arrange, conduct, carryout, assist any type of fund raising programmes and activities to augment requirement of funds and income for the advancement of the object of the trust.
- g) To receive voluntary donations, subscriptions or funds in any form from the public for augment of Trust funds.
- h) To purchase or acquire or get allotted any property movable or immovable either on lease or in any manner for the purpose of Trust.
- i) To establish and to maintain of orphanage, homes especially for women, mentally retarded or physically disabled children.
- j) To establish an alleviation centre for woman deprived either because of disability or harassment by her relatives, employees in the workplace etc.
- k) To do all that is necessary and incidental for the purpose of achieving the objects herein above mentioned.

- V. **The Trust created is irrevocable.**
- VI. The Trustee 2, Mrs. Saumya Sajan would be carrying the functions of The Treasurer behalf of this Trust.
- VII. The Trust shall be non-political, non-sectarian, non-commercial, non-profitable and non-racial organisation. The benefits of the trust shall be open to all irrespective of caste, creed or religion.
- VIII. The Trust objects shall be independent of each other and the Board of Trustees herein constituted may from time to time, apply funds for the Trust in carrying out all or any of the objectives of the trust as it may, its absolute discretion, deem fit.
- IX. The number of Trustees shall be neither less than 3 (Three) not more than 7 (Seven)
- X. All the Trustees who are for the time being and from time to time, in office shall constitute and be referred to collectively as the BOARD OF TRUSTEES or the BOARD.
- XI. The Board shall be competent to transact all and every business of the Trust notwithstanding any vacancies in the Board.
- XII. The Trustees shall have power to augment the funds of the Trust from any source whatsoever by accepting Gift, Building/s, Voluntary Contributions or any kind of help if in the opinion of the

Managing Trustee, such acceptance will be in the interest of the Trust.

- XIII. To open one or more Bank accounts in the name and for the Trust any wherein India, such account or accounts shall be operated by the Managing Trustee and the Trustees jointly. To incur all such expenses that are necessary for the execution of the objectives of the Trust and powers under these presents.
- XIV. To raise donations or accept gifts or contributions in cash or in kind.
- XV. To appoint such staff as may be necessary for the due administration of the Trust on such remuneration, commission or salary as the Trustees may think proper and remove or replace them whenever necessary.
- XVI. To frame time to time for the regulations of the various activities of the Trust and alter or rescind the same whenever necessary. No amendments to the Trust Deed shall be made which may prove repugnant to the provisions of Sections 2(15), 80G and / or any other provisions of the Income-tax Act, 1961. However, no amendment shall be carried out without the prior approvals of the Commissioner of Income-tax.



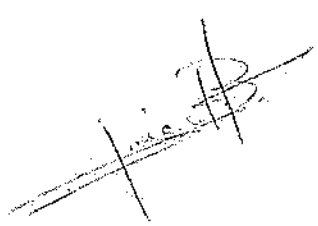

The Managing Trustee shall arrange for the maintenance of correct and proper accounts of the receipts and disbursements and/or the liabilities incurred and of the assets acquired and for an audit every year ending on 31st March of the accounts of the Trust and of the Income and Expenditure relating thereto and for this purpose, the Managing Trustee shall appoint in consultation with the Board an independent Chartered Accountant.

XVII. No act of the Managing Trustee done in exercise of the power hereby specifically conferred on him shall be called in question or interfered or interfered by the Board, except on the ground of its manifest impropriety or on the ground that it is gross breach or neglect of duty on the part of the Managing Trustee. The Quorum for a meeting of the Board shall be three.

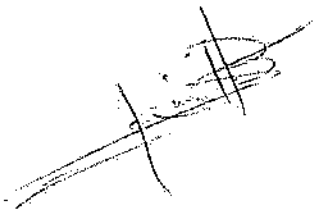
XVIII. Subject to the provisions of the Deed, the Board is hereby authorised to and they may from time to time, make and prescribe rules and bye-laws for the carrying out of the objects of the Trust and for the administration of the affairs of the Trust and allied institutions maintained, managed, controlled and/or conducted by the Trust and all other matters incidental to the working of the Trust, and from time to time modify, add, alter or amend such rules, regulations and bye-laws.







- XIX. If the objects for which the Trust has been created/should fail and become impossible of performance, the Trustees shall be at liberty to dissolve or wind-up the trust. In the event of dissolution or winding up of the trust, the assets remaining as on that date shall under no circumstances be distributed among the Trustees, but the same shall be transferred to another charitable trust, society, association of person, or institution whose objects are similar to those of this Trust and which enjoys recognition under Section 80G and/or any other Sections of the Income-tax Act, 1961, as on such date.
- XX. The Trustees shall conform to the provisions of the Indian Trust Act, in all matters not expressly provided for herein, but in case any difficulty or doubt arises on any question in respect of the management or administration of the Trust or any matter falling herein above, the Managing Trustee may on behalf of the Board, apply to the Court for opinion, advice, direction or order and the Trustees acting upon the direction, if any of the Court, shall be deemed so far as regards their responsibility to have discharged their duties in respect thereof.
- XXI. The Trustees shall not be personally liable for any act that is done with a bonafide intention and good faith on behalf of Trust in the course of duties as a Trustee.
